  - A. New budget FY 22 is approved. Minimum wage has increased for the new fiscal year. State money has increased, so we are shifting as much as we can to those funds in order to keep staff funded with the new wage increase.
  - B. Covid cares grant and Arpa proposal: 1<sup>st</sup> covid grand was used to buy hot spots and chromebooks. They are in circulation and doing well. 2<sup>nd</sup> covid grant in process now. Money will be spent for more data for existing hot spots and chromebooks and on recording studio equipment for patrons to reserve to stream or record Vlogs, zoom meetings, job interviews, etc.
  - C. Covid update: We are open for our full hours minus one evening at Chase City and one evening at Clarksville.
  - D. Internet/Phone update: July 1<sup>st</sup> was to be the date for a switch to Granite for SH, CC and BO. SH and CC made the transition the 2<sup>nd</sup> week of July, BO still waiting. This is to keep our e-rate where the state reimburses the library 80% of the internet bill. The internet speed is increased significantly with the change. CL has a new Shentel service.
