# NATCHITOCHES PARISH LIBRARY BOARD OF CONTROL MEETING MINUTES July 15, 2014

#### **Minutes**

Motion to approve the April 8, 2014 Library Board of Control Minutes as presented was made by Mr. Roque. Dr. Burns second. Motion Carried.

#### Guests

Dr. Leon Davis presented the Library Board with a proposal for the creation of a research library that concentrates on African Americans. Research library would be a satellite library of Natchitoches Parish Library that concentrates on books & materials on African Americans. Later on African American Research Library that is devoted to the history and culture of African Americans (Auburn Avenue Research Library & African American Museum in Atlanta, GA). Dr. Davis will orchestrate and setup a Satellite Library. Dr. Davis stated that his proposal would be a form of affirmative action due to African Americans not being represented in the library, administration or staff when the library was created.

Roque motioned to take Dr. Davis proposal under advisement for further study. Roque stated that Dr. Davis had done what the library board has requested. Roque stated the library would receive Dr. Davis proposal. Roque stated that the library board and staff would see what if any the library board could do to address Dr. Davis' concerns.

### **Campti Branch**

Mr. Minturn presented the library board with a preliminary drawing of proposed floor plans for Campti Branch building. Preliminary plans had 10 computers in the adult lab and 3 computers in the children's lab. Mr. Roque would like to have more computers for patrons.

Mrs. Jenkins stated that the Library Manager would probably need a private desk, possibly in the staff lounge.

Motion to accept the floor plans with modifications made by staff was made by Dr. Burns. Mrs. Jenkins second. Motion Carried.
